
#### Spanish and French IMDG Code Amendment 40-20 ereaders now available!

## **IMO Digital publications update**

Exis is an authorised reseller of digital IMO publications. The International Maritime Organization has been updating several of its publications.

**IMO Vega database Version 25** developed jointly by IMO and DNV GL AS, includes up-to-date texts of core IMO requirements (including IMDG Code, SOLAS, MARPOL and IAMSAR manuals) as well as pollution prevention and safety-related documents in English. Version 25 includes amendments adopted by MEPC 75 and MSC 102, both held virtually in November 2020.

The **SOLAS Consolidated Edition 2020 e-reader** in English, French and Spanish have also been updated. SOLAS is an essential reference for maritime administrations, ship manufacturers, owners and operators, shipping companies, education institutes and all others concerned with the International Convention for the Safety of Life at Sea (SOLAS).
