


National Cargo Bureau celebrates 70 years of helping to enforce regulatory advancements with a mission of Safety of Life and Cargo at Sea

Exis Technologies parent company, NCB, is proud to be celebrating its 70th anniversary this year. Over the past 70 years NCB has helped to enforce important regulatory advancements with its mission of the Safety of Life and Cargo at Sea. NCB is mentioned in several of the Code of Federal Regulations. Certificates issued by NCB for bulk cargoes may be accepted as evidence of compliance with the IMBSC Code and US regulations under 46 CFR.

Since 2018 when Exis became part of the NCB Group, the two companies have joined forces to tackle the issues at the root of ship fires, like poor stowage and misdeclared/undeclared DG with new digital solutions. <u>Hazcheck Inspections</u>, the web-based container inspections database now has an excess of 100,000 data records and CTUs can be inspected remotely using their new remote inspections capability using mobile phones to capture data.
